Dear Sunman-Dearborn Community Schools Parents:

On Thursday, April 2nd, Governor Holcomb signed Executive Order 20-16. The order states “All K-12 schools in Indiana shall provide instruction via remote learning for the remainder of the 2019-2020 school year, and school buildings shall remain closed.” In addition, schools are required to complete either one-hundred sixty (160) days of instruction, or at least twenty (20) additional days of remote learning between the date of the executive order (today) and the end of the school year.

When schools were ordered to close until May 1st, we anticipated that it could potentially be extended. Knowing this, we developed a revised school calendar that would enable us to extend e-learning until the end of the school year if needed. As a result, I will recommend the attached calendar for approval at the April 9th board meeting.

Internet Access

As a reminder, a limited number of Verizon Mifi devices will be available for parents if no other internet option exists. These units are ordered, and we expect the delivery in early April. If you are interested in receiving a Mifi device, please email Ms. Cindy Morton at cmorton@sunmandearborn.k12.in.us.

Chromebook Support/Repairs

We have developed a form for parents to use for Chromebook support. If you are having any issue at all, please complete the form. The form can be accessed through the COVID-19 webpage linked at the bottom of the letter. A member of our IT department will contact you. If the Chromebook needs repair, they will schedule a date and time during school office hours on Monday and Thursday from 9:00 AM - 2:00 PM for you to bring the Chromebook to school to drop off and pick up a temporary replacement.

The principal or administrative assistant will meet you at your car with a spare Chromebook to use until the other Chromebook is repaired. You will receive an email notification when the Chromebook is repaired and ready for pickup. Again, please stay in your car. The principal or administrative assistant will meet you at your car.

Food Service

In an effort to limit the number of employees working at school, we will eliminate the Sunman Elementary and Bright Elementary locations for meal pickup. East Central High School will be

the only pick-up location. We have also adjusted the days to Tuesday and Thursday. Times will remain the same; 11:00 AM - 1:00 PM and 4:00 PM - 6:00 PM.

Building Office Hours

Per Governor Holcomb's Executive Order, most employees will be working from home through the end of the school year. Each school building will be open on Monday and Thursday from 9:00 AM - 2:00 PM with a limited number of staff working. All parents are asked to call during office hours, or email the administrative assistant or principal for assistance or to schedule an appointment. Access to the building will be limited to essential employees and scheduled visitors only. You can access an email and phone directory on each school's webpage.

School Activities/Events

All school activities, events, fundraisers, etc, for the remainder of the school year are cancelled.

Kindergarten Registration

A revised plan and dates for Kindergarten Registration will be announced in May.

3rd Quarter Report Cards

3rd Quarter report cards will be posted in the PowerSchool Parent Portal by Friday, April 10th. They will not be mailed. You will be able to access the report card by logging in and clicking on Report Cards, on the left hand menu.

Student Items

More information will be coming in early May regarding a plan for student items left at school.

Graduation

We will continue to monitor the situation to determine if a traditional graduation ceremony can still occur, or if it will need to be some sort of non-traditional graduation ceremony.

In addition, per Dr. McCormick's announcement, all seniors will receive credit for any course they are currently enrolled in. However, seniors are still expected to participate in e-learning to establish grades for their transcripts.
